Introduction

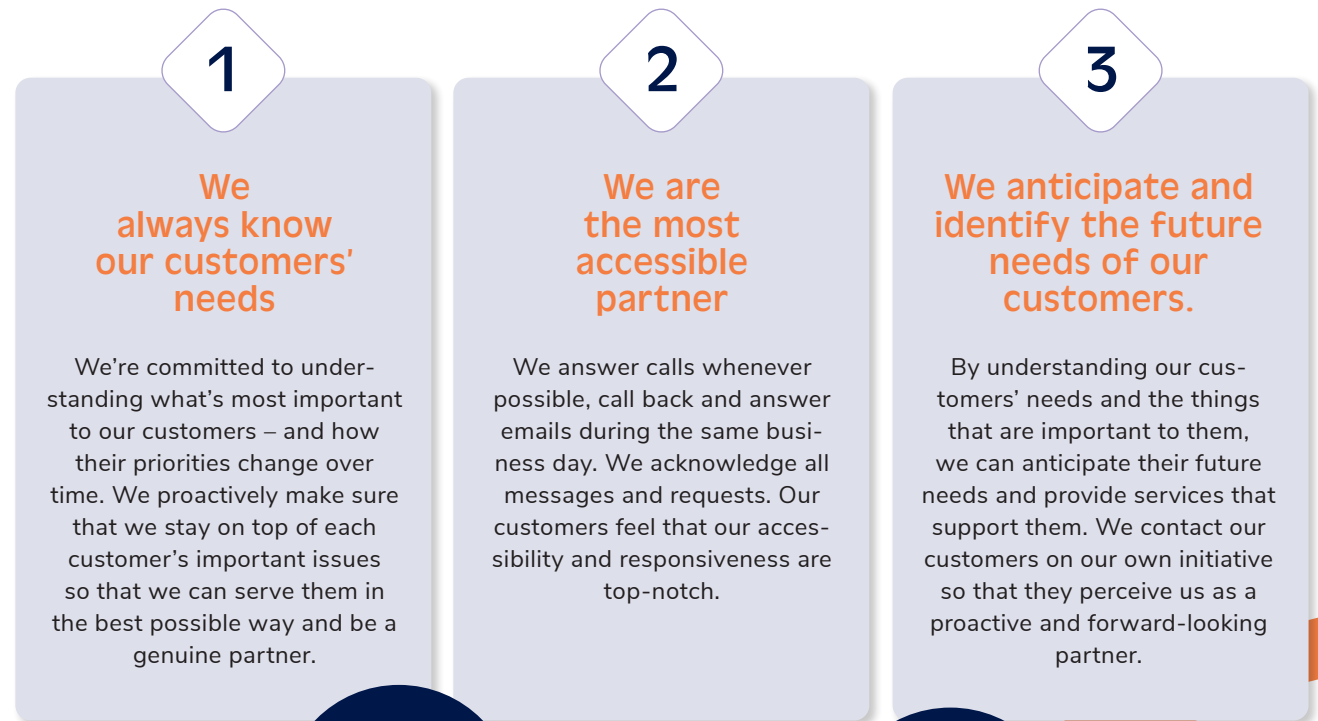

Material delivery schedule and delivery channels

The Customer must submit the necessary material using Talenom's material submission channels in line with Talenom's specified schedule for the service to be provided according to the agreed timetable. If the material is submitted late, Talenom will reschedule the completion of the service. Talenom is entitled to charge any additional costs arising from processing late or incorrectly delivered material. Talenom is not liable for the consequences of late submissions.

Material quality and format requirements

The Customer is responsible for the clarity, completeness, accuracy and compliance of the material submitted. If necessary, the Customer must supplement the submitted material. For example, additional clarifications, translations or additional documents may be required. Talenom is entitled to charge any additional costs arising from processing ambiguous or incomplete material. Talenom is not liable for the consequences of ambiguous or incomplete material.

Work done by the Customer or a third party

If the Customer prepares part of the bookkeeping themselves, the Customer is liable for its accuracy and legality and for maintaining records of the partial accounts as required by regulations. Talenom will not verify the accuracy of partial accounting unless otherwise agreed in writing. In addition, Talenom will not review the Customer's specified bookkeeping accounts, tax rates, or monitoring objects in the financial management system from which the transactions are transferred to bookkeeping after posting. Talenom charges an additional fee for correcting errors in partial accounting or posting carried out by the Customer.

Retention of bookkeeping and payroll material

During the customer relationship, Talenom will retain the bookkeeping material in accordance with the requirements of Finnish legislation. Talenom Online allows the Customer to view and download the bookkeeping material. At the end of the customer relationship, the Customer is responsible for downloading and retaining the bookkeeping material, unless otherwise agreed in writing.

Payment Terms and Delay Consequences

The payment term is 10 days from the invoice date, and late payment interest will be charged in accordance with the Interest Act. Collection costs may be charged for overdue payments. Any objections to invoices must be made in writing within ten (10) days from the invoice date.
